

**St. James Memorial Garden
Greenville, SC**

Regulations

Purpose

The purpose of the Memorial Garden is to offer a tranquil area for rest and meditation, and to provide for the interment of ash remains.

Interment

1. There are no restrictions, subject to the following regulations, as to who may be interred within the Garden.
2. The ashes are interred directly into the ground; no urns of any type are used for burial.
3. The place of interment in the Garden shall follow a plan adopted by the Memorial Garden Committee. No particular place may be chosen or designated by the applicant.
4. The name of each person whose remains are interred in the Garden, with dates of birth and death, will be listed on an individual cast bronze nameplate on the high brick wall of the Garden. No individual markers will be permitted in the Garden.
5. The basic design, planning, planting, and arrangement of the Garden shall at all times be under the supervision of the Garden Committee, subject to the final approval of the St. James Vestry.
6. Contributions for additions or improvements will be gladly received by the Garden Committee, subject to Regulation 5 above.

How to Apply

Arrangements for the interment of ash remains, either your own or those of another person, may be made by filling out and signing the application (*over*). The application must be given to the Rector or the Parish Secretary. It must be accompanied by a fee of \$100 plus the cost of the plaque, check payable to St. James Episcopal Church, with "Memorial Garden" listed in the memo line. If this amount constitutes a hardship, all or part of the fee may be waived at the Rector's discretion. This fee covers nameplate, interment, and care of the Garden. An acceptance will be issued, which, together with the Application, constitute a contract between the Applicant and St. James Episcopal Church. The original of the contract will be filed at the Church and a copy will remain with the Applicant.
